

AND ON HEARING Tim Ward for Vodafone, Kelyn Bacon for Telefonica, Jon Turner QC and Meredith Pickford for T-Mobile, Marie Demetriou for Orange, David Anderson QC and Sarah Ford for BT, Tom de la Mare for OFCOM IT IS ORDERED that:

- 1) the Competition Appeal Tribunal's directions to OFCOM, given under paragraph 82 of their decision dated 2 April 2009 at [2009] CAT 11, be set aside insofar as those directions required OFCOM to impose revised price controls for the period prior to 3 April 2009;
- 2) the revised price controls published by OFCOM on 2 April 2009 in accordance with the said directions, expressed to take effect from 3 April 2009, be declared to be ultra vires insofar as those revised price controls apply to the period prior to 3 April 2009;
- 3) British Telecommunications plc shall pay each of the Appellants' costs in



the Court of Appeal, to be the subject of detailed assessment if not agreed;

- 4) there be no order as to OFCOM's costs;
- 5) permission to appeal to the Supreme Court of the United Kingdom be refused.
