**AND UPON** the 6<sup>th</sup> to 10<sup>th</sup> Defendants and Second Named Fourth Party having in writing agreed to the terms of this Order as set out below.

**IT IS ORDERED BY CONSENT THAT:**

1. The 6<sup>th</sup> to 10<sup>th</sup> Defendants will file and serve their Amended Particulars of Additional Claim (the “Additional Claim”) in respect of the Second Named Fourth Party by 4pm on 19 March 2021.
2. The Second Named Fourth Party will file and serve its Defence in relation to the Additional Claim (the “Defence”) by 4pm on 30 April 2021.
3. The 6<sup>th</sup> to 10<sup>th</sup> Defendants may file and serve a Reply to the Defence within 21 days of filing and service of the Defence.
4. There be no order as to costs.
5. The parties are at liberty to apply to vary the terms of this order.
