2. Within 28 days of the handing down of judgment in the hearing of the summary judgment and counterfactual amendment applications (scheduled to be heard across 12–14 May 2021), the Claimants will serve the fourth wave claimant-specific quantum schedules.
3. The Defendants are required to file their defences within 14 days thereafter.
4. The Claimants are required to file any replies within 14 days thereafter.
5. The Defendants are not required to file with their defences an annex of documents referred to therein (as would otherwise be required by Rule 35(3) of the Competition Appeal Tribunal Rules 2015).
