**UPON** the Tribunal having directed that the trial, pursuant to paragraph 29 of the CMC Order, be listed to commence on 27 June 2022 with a time estimate of five weeks

**AND UPON** the parties having agreed to the terms of this Order in writing

**BY CONSENT IT IS ORDERED THAT:**

1. The deadline under paragraph 24(a) of the CMC Order, by which the parties’ experts shall simultaneously exchange signed reports, shall be amended to 1 October 2021.
2. The deadline under paragraph 24(b) of the CMC Order, by which the parties’ experts shall simultaneously exchange signed reply reports, shall be amended to 26 November 2021.
3. The experts without prejudice meeting, pursuant to paragraph 25 of the CMC Order, shall take place by 17 December 2021.
4. The deadline under paragraph 26 of the CMC Order, by which the parties’ experts shall complete the joint memorandum following their without prejudice meeting, shall be amended to 28 January 2022.
5. The deadline under paragraph 28 of the CMC Order, by which the parties shall complete the preparation of trial bundles, shall be amended to 8 April 2022.
