**AND HAVING REGARD TO** the Order of the Honourable Mr Justice Trower dated 22 January 2021, as subsequently amended, including by the Order of the Honourable Mrs Justice Joanna Smith dated 29 November 2021 (the “**Third Parties Disclosure Order**”)

**BY CONSENT IT IS ORDERED THAT:**

1. The Third Parties Disclosure Order be varied as follows:

(a) The wording at paragraph 14.2 be replaced with:

*“the Prysman Defendants’ Expert shall serve their report by 4pm on 1 June 2022.”*

(b) The wording at paragraph 14.3 be replaced with:

*“the Third Parties’ Expert shall serve their report by 4pm on 8 July 2022.”*

(c) The wording at paragraph 14.4 be replaced with:

*“the Claimants’ Expert shall serve their reply report by 4pm on 26 August 2022.”*

(d) A new paragraph 14.5 be added with the following wording:

*“the joint meeting of experts shall be held on 5 September 2022.”*

2. The CMC Order be varied as follows:

(a) The wording at paragraph 23 be replaced with:

*“The joint memorandum of the Experts shall be completed by 4pm on 16 September 2022.”*
