AND UPON the Tribunal having determined that certain questions arising out of the judgment of the CJEU in Case C-267/20 Volvo AB (publ.) and DAF Trucks NV v RM EU:C:2022:494, as set out in the Tribunal's "List of Questions" document dated 20 February 2023, should be decided as preliminary issues in Case No. 1517/11/7/22 (UM) Merchant Interchange Fee Umbrella Proceedings (the "Volvo Issues") and having listed a hearing for that purpose on 24 – 26 April 2023

AND UPON the Defendants' applications by letter dated 16 February 2023 to challenge certain pre-service amendments to the Claim Forms in the SH Interchange Fee Proceedings pursuant to CPR rule 17.2(2) ("CPR Rule 17.2(2) Application) and to strike out certain parts of the Particulars of Claim in the SH Interchange Fee Proceedings pursuant to CPR rule 3.4 or Rule 41 of the Competition Appeal Tribunal Rules 2015 (the "Strike Out Application", and together the "Defendants' Applications")

AND UPON the parties having agreed that the Defendants' Applications should not be heard until after the Volvo Issues have been finally determined

AND UPON considering the letters from Stephenson Harwood LLP dated 24 February 2023

and 27 February 2023

AND UPON considering the letter from Jones Day dated 7 June 2023 seeking to adopt the Strike Out Application in Case 1591/5/7/23 (T) iHerb LLC and others v Mastercard

Incorporated and others

AND UPON considering the letter from Jones Day dated 16 June 2023 seeking to strike out the claimants' claims in relation to certain of Mastercard's scheme rules and the letters dated

16 and 19 June 2023 from Stephenson Harwood LLP and Jones Day respectively

IT IS ORDERED BY CONSENT THAT:

1. The Defendants' Applications, including the Strike Out Application adopted in Case

1591/5/7/23 (T), be stayed pending the final determination of the Volvo Issues, which
