**ORDER**

UPON the parties having agreed the terms of this Order

AND UPON the Sixth to Ninth Defendants having filed (i) a Notice of Additional Claim against the First to Fifth Defendants and (ii) an Additional Claim against the Third Parties on 24 April 2020 (the “Additional Claims”)

**AND UPON** the Tribunal’s Order drawn on 15 March 2021 that the proceedings in this action (including the Additional Claims) be stayed until 56 days after the date on which judgment is handed down in Royal Mail Group Limited v DAF Trucks Limited & Others (Case No: 1284/5/7/18 (T)) and BT Group PLC & Others v DAF Trucks Limited & Others (Case No: 1290/5/7/18 (T)) (the “**Royal Mail and BT Group Proceedings**”)

**AND UPON** the judgment in the Royal Mail and BT Group Proceedings being handed down on 7 February 2023 and the current stay having expired on 4 April 2023

**AND UPON** the First Third Party ceasing to exist as an independent legal entity following its merger into TRATON SE by registration in the commercial register at the Munich Local Court (Amtsgericht) (HRB 246068) on 31 August 2021

**IT IS ORDERED BY CONSENT THAT:**

1. Subject to contrary order of the Tribunal, all further proceedings in this action (including the Additional Claims) be stayed for a further four months, until at least 4 August 2023, from which date the stay may be lifted by any Party upon provision of written notice to the other Parties.
2. There be liberty to apply.
3. No order as to costs.
