ORDER

AND UPON the Class Representative and the Defendants (the “**Settling Parties**”) filing an application for a collective settlement approval order on 17 January 2025 (the “**CSAO Application**”)

AND UPON the Tribunal’s Order of 22 January 2025 setting out directions for the Settlement Hearing (the “**Directions Order**”)

AND UPON the Tribunal's Order of 23 January 2025 granting permission to the First Intervener to intervene in the Collective Proceedings, limited to the determination of the determination of the CSAO Application, and to file its statement of intervention and any evidence on which it wishes to rely by 4pm on 3 February 2025

AND UPON the Tribunal's Order of 29 January 2025 granting permission to the Second Intervener to intervene in the Collective Proceedings, limited to a written statement of intervention regarding the determination of the CSAO Application, and to file its statement of intervention by 4pm on 7 February 2025

AND UPON reading the letter from the solicitors for the Defendants dated 28 January 2025 and the letter from the solicitors for the First Intervener dated 30 January 2025

AND UPON Mr Roger Chappell, a Represented Person, informing the Tribunal pursuant to paragraph 3(a) of the Directions Order that he will be applying for permission to make oral or written submissions regarding the CSAO Application

AND UPON the Directions Order providing pursuant to paragraph 3(b) that the application for permission by a Represented Person together with written submissions he/she is applying to make shall be filed by 7 February 2025

IT IS ORDERED THAT:

1. The Settling Parties shall file their responses to the First Intervener's statement of intervention, including any evidence in reply, by 4pm on 11 February 2025.
2. The Settling Parties shall file their responses, if any, to the Second Intervener and to any written submissions by Mr Chappell if permission to file such submissions is granted by 4pm on 12 February 2025.
3. The First Intervener is permitted to file a skeleton argument by 4pm on 14 February 2025.
4. The First Intervener shall serve a non-confidential version of its statement of intervention and evidence on Mr Chappell by 4pm on 5 February 2025. Such service may be made by email.
