

ON READING the Appellant's Notices sealed on 12th March 2007 filed on behalf of Dŵr Cymru Cyfyngedig applying for permission to appeal and an extension of time from the judgments of the Competition Appeal Tribunal dated 6th October 2006 and 18th December 2006 and the skeleton argument and statement pursuant to paragraph 4.14A(2) of the practice direction supplementing CPR Part 52 dated 19 July 2007

AND ON HEARING Mr Christopher Vajda QC of Counsel on behalf of the Appellant and Mr Rhodri Thompson QC and Mr John O'Flaherty of Counsel on behalf of the Respondent and Mr Rupert Anderson QC and Ms Valentina Sloane of Counsel on behalf of the Water Services Regulation Authority (formerly Director General of Water Services)

#### IT IS ORDERED that



1) the applications for permission to appeal and an extension of time be granted on the following two issues: (a) whether the Tribunal applied the wrong legal test for a margin squeeze

in its judgments of 6<sup>th</sup> October 2006 and 18<sup>th</sup> December 2006;

- (b) whether the Tribunal erred in law in finding that paragraph 3(2) of Schedule 8 to the Competition Act 1998 conferred jurisdiction on the Tribunal to decide the issue of dominance in its judgment of 18<sup>th</sup> December 2006;
- 2) the Appellant lodge amended grounds of appeal to reflect the judgment of this Court of 26th July 2007;
- 3) costs of the permission hearing be costs in the appeal.

#### IT IS DIRECTED that

1) the appeal be listed for two days

- 2) the appeal be heard by three judges, one of whom may be a High Court judge, and with one of those judges being a competition law expert if
- 3) hearing of the appeal be expedited and if possible be listed for hearing during Michaelmas term 2007

### IT IS FURTHER DIRECTED that



- 1) the Appellant provide a core bundle for the appeal, along the lines of the core bundle prepared for the permission hearing on 26th July 2007
- 2) the Appellant provide an introductory note for the benefit of the Court, with a reading list and relevant passages identified and marked up in the core bundle, that note to be agreed with the Respondent if possible
- 3) the Water Services Regulation Authority provide the Office of Fair Trading and regulators with concurrent powers under the Competition Act 1998 with copies of the Appellant's amended grounds of appeal and the judgment of the Court dated 26th July 2007 granting permission to appeal
- 4) written submissions from the Office of Fair Trading or any other regulator be lodged within one month from receipt of the Appellant's amended grounds of appeal and the judgment of the Court
